About CIO-CS GWAC

CIO-CS is a \$20 billion, 10 year, Government-Wide Acquisition Contract (GWAC) for IT commodities and solutions that can be used by any federal civilian or Department of Defense agency to fulfill mission critical requirements while meeting fiscal goals. CIO-CS covers everything IT Service Management (ITSM) and offers streamlined access to pre-vetted providers at pre-negotiated prices. The contract is administered by the National Institutes of Health Information Technology Acquisition and Assessment Center (NITAAC).

CIO-CS Ordering Process

Procurement orders are sent directly to the Contract Holder upon award. Contract Holder must upload the order into the NITAAC's Electronic Government Ordering System (e-GOS) before processing it.

STEP 1

End User or Contracting Officer

1. Determines best value through market research.
2. Creates Delivery Order citing CIO-CS Contract# HHSN316201500050W and Affigent.
3. Sends order to Contract Holder.

STEP 2

CIO-CS Contract Holder

1. Verifies order.
2. Uploads order into the NITAAC e-GOS system.
3. Processes order.
4. Delivers equipment and services.
5. Invoices Agency or Contractor.
